

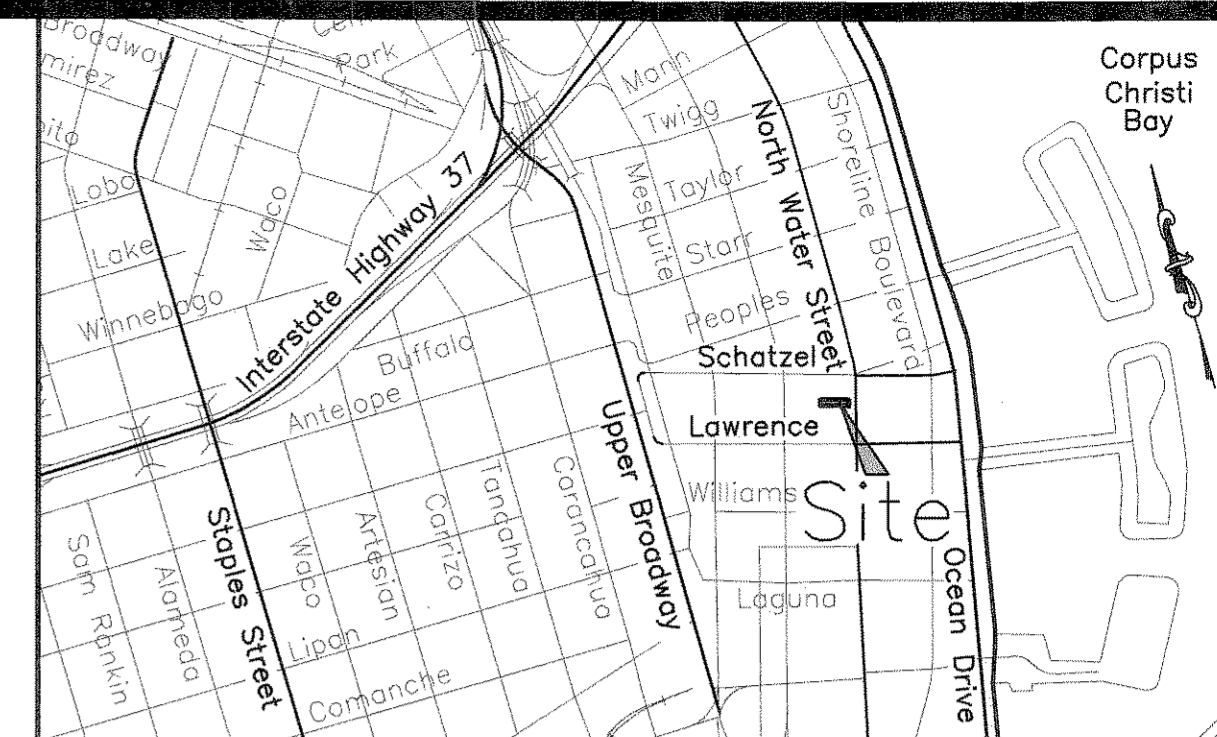
Notes:

- Total platted area contains 0.104 acres of land.
- Set 5/8 inch iron rods with red plastic cap stamped "URBAN ENGR C.C. TX" at all Lot corners, except where noted.
- The receiving waters for storm water from this property is the Corpus Christi Bay. The TCEQ has classified the aquatic life use for the Corpus Christi Bay as "exceptional" and "oyster waters". TCEQ also categorized the Corpus Christi Bay as "contact recreation" use.
- Bearings are based on the recorded plat of Lots 1-A, Block 12, Beach Portion, a map of which is recorded in Volume 56, Page 37, Map Records of Nueces County, Texas.
- By graphic plotting only, this property is in Zone "B" on Flood Insurance Rate Map, Community Panel No. 485464 0167 C, City of Corpus Christi, Texas, which bears an effective date of July 18, 1985 and is not in a Special Flood Hazard Area.
- If any lot is developed with residential uses, compliance with the Public Open Space regulations will be required during the building permit phase.

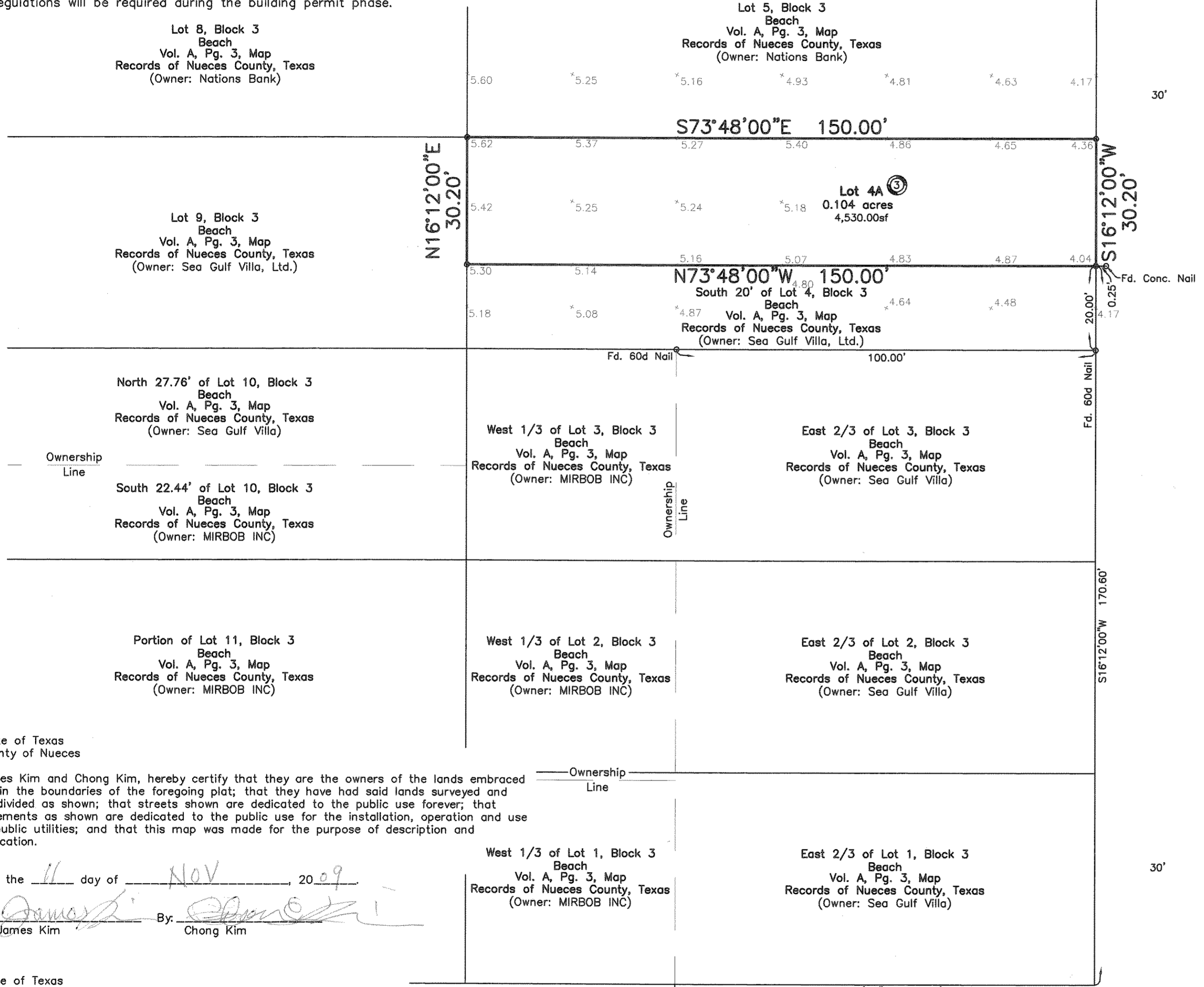

LOCATION MAP N.T.S.

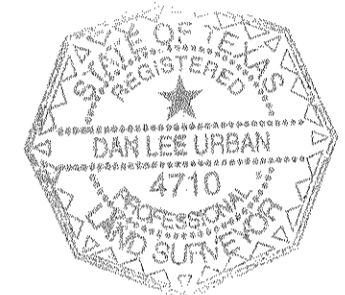
